# 1. DEFINITIONS AND INTERPRETATION

**Interpretation:** Capitalized terms shall have the meanings defined hereunder. The following definitions shall have the same meaning regardless of whether they appear in singular or plural.

Definitions: For the purposes of this Privacy Policy, the terms stipulated below shall have the following meaning:

- 1.1. Associates shall mean Meethaq Islamic Banking's employees, officers, directors, associates and agents;
- 1.2. Browser shall mean a computer program with a graphical user interface for displaying and navigating between web pages;
- 1.3. Clickstream shall mean a user's activities on the World Wide Web as represented by the sequence of links they click on;
- 1.4. Device shall mean any electronic device used for the purposes of accessing the Website;
- 1.5. Internet shall mean a global system of interconnected computer networks that uses a specific protocol to communicate between networks and devices;
- 1.6. ISP shall mean Internet Service Provider;
- 1.7. Meethaq (can be referred to us "We", "Us", or "Ours" in this Policy) shall mean Meethaq Islamic Banking, a public joint stock company, duly registered in accordance with the laws of the Sultanate of Oman under commercial registration number 1/14573/8, and having its registered address at P.O. 134, Postal Code 112, Ruwi, Sultanate of Oman;
- 1.8. OS shall mean Operating System of a Device / Personal Computer;
- 1.9. Personal Data shall mean any identifiable personal information that pertains to an individual;
- 1.10. **Privacy Promise** shall mean the bank commitments to take a sequence of actions to avoid or treat a specific privacy concerns for its customers;
- 1.11. Products and Services shall mean the features and offering available in Meethaq applications and web sites;
- 1.12. **Profiling Information** shall mean the process of construction and application of user profiles generated by computerized data analysis. This is the use of algorithms or other mathematical techniques that allow the discovery of patterns or

correlations in large quantities of data, aggregated in databases. When these patterns or correlations are used to identify or represent people, they can be called profiles;

- 1.13. **Retention Period** shall mean the records life cycle that identifies the duration of time for which the information should be maintained or "retained," irrespective of format (paper, electronic, or other);

- 1.15. You/User/Person shall mean the individual or entity accessing or using Meethaq Islamic Banking's online platform.

# 2. USAGE OF PERSONAL DATA

- 2.1. Meethaq will safeguard, according to strict standards of security and confidentiality, any information our customers share with us.
- 2.2. Occasionally, Meethaq may collect personal information from visitors who voluntarily submit personal information to us. We may use such information for sending such visitors details of our banking Products or Services, and other marketing materials which may be of interest to such Users, or invite such Users to participate in market research and surveys and other similar activities.
